# **Exhibit Rules & Regulations**

NACA has contracted GES to manage the exhibit process. The exhibitor kit will be provided once full payment has been received.

The following rules and regulations are a part of the 45th NACA Annual Convention's Exhibitor's Application and Contract. Please provide a copy of these Rules and Regulations to the person(s) responsible for the setup of your booth(s).

#### Assignment of Space

Assignment of exhibit space and sponsorship will be on a first paid, first-served basis. Every effort will be made to accommodate requests for booth assignments.

Exhibit Fees and Payment Applications will not be processed without the required payments and signature. All applications must be accompanied by full payment on or before December 15, 2020. Payments received after that date will be assessed a \$100 late fee. Receipt of payment does not obligate NACA to accept a contract as binding. NACA retains the option of returning funds.

#### **Exhibitor Cancellation**

Cancellations of sponsorship or exhibit space must be directed in writing to Joelle Ward at Joelle.ward@conferencedirect.com by December 15, 2020. Refunds, less an administrative fee of \$100, will be made at the discretion of NACA, but no refund will be given for a cancellation after December 31, 2020.

#### Shipping

GES will provide shipping instructions and other important information as determined.

#### **Exhibitor Registration**

Name badges for two (2) people are included with each booth. Additional badges may be purchased for \$300 each. Each name badge admits one person to the exhibit hall only. All exhibitors must register online.

#### Use of Space

Exhibitors shall not assign, share, or sublet any space without written consent from NACA. Care must be taken that no booth display(s) extends more than 8' above the floor or more than 8' in depth from the back wall of the booth or interferes with the view of other exhibitors. Noticeable noise produced from operation of any equipment or apparatus is not permitted.

NACA and Rio All-Suites Hotel and Casino will not be held responsible for the safety of the property of the exhibitors from theft, fire, damages, accident or other causes.
