Gene Eberl - 1930-2009

Gene Eberl, NACA Past President (1985-1986), passed away on Saturday, September 12<sup>th</sup>. Gene joined the association in 1979 and served on the Constitution & By-Laws Committee and 7 terms on the Grievance Committee during his membership.

The following is from Eberl Claims Service:

It is with great sorrow that we announce the passing of the patriarch of the Eberl Family, Gene beloved husband. father. Eberl, grandfather. Gene was the cornerstone of the Eberl Family and instrumental in the formation and development of Eberl Claims Service. He was a mainstay in the catastrophe claims industry earning the respect and admiration of clients, adjusters and competitors, across country. From his early days at Rocky Mountain Adjustment Company to his retirement from Eberl Claims Service, Gene was a respected leader, a trusted resource, a wealth of knowledge, and a reliable business partner who never compromised his values of integrity and honesty. Gene was an active member in the adjusting community, serving as President of the National Association of Catastrophe Adjusters, as well as participating as a member and associate of several other claims associations. He was a personality in our adjusting community that will never be replaced.

For all of the accomplishments that Gene achieved in the insurance adjusting business, he was a family man first and foremost. Even as a young man, Gene began developing the nucleus around which the family was built. With 4 children, 12 grandchildren, 25 great grand children, and 2 great-great children (and counting), it was a big job to bring the entire family together but Gene and his wife, Alberta, never tired of organizing and hosting the family gatherings time and time again. Spending time with family, teaching the children, and instilling the values that made him who he was in the people that loved and looked up to him was what made Gene so special. It was that dedication to family and values that made him the man he was. To put it plainly, he taught us how to live right. He was a very special person, and he will be dearly missed.

Walter Eugene "Gene" Woodrick - 1931 – 2009

Gene Woodrick, NACA Life Member and Past President (1981), passed away on November 6<sup>th</sup> at Slidell Memorial Hospital. Gene joined the association in 1978 and served on the Grievance Committee, 2<sup>nd</sup> Vice President, Vice President, and the Convention Committee.

Gene was born in Meridian, MS, the son of Joseph A. Woodrick, SR. and Annie West Woodrick both of whom preceded him in death. After graduating from Meridian High School he was called into the service with the 198th tank battalion during the Korean War. Upon discharge he attended MS Southern College, obtaining a degree in Business Administration. He then began a career of Insurance Adjusting, first with Crawford and Company then with H.B. Wellborn and Company. He went into business on his own in 1962 in Greenville, eventually returning to Hattiesburg in operate as Wellborn-Woodrick 1969 to Associates, offices in Hattiesburg, Greenville, Natchez as well as Jackson and Montgomery, AL. The business was sold in 1975 after an unsuccessful bid for election as Insurance Commissioner. Since 1975 he has operated a nationwide catastrophe adjusting business which included much work for FEMA and the National Flood Insurance Program from Hawaii to Puerto Rico and most states in between. He retired in 2004 after 49 years of adjusting. Since 1986 he has lived on the Gulf Coast, primarily in Bay St. Louis. During his claims career he was a member of the National Association of Independent Insurance Adjusters. awarded was Membership in the MS Claims Association. He was a member of the Gulfport Elks Lodge #978.

He is survived by his wife of 29 years, Sue Aultman Woodrick, his children, Larry Woodrick of Brandon, MS, Kimbrell Woodrick of Sieverville, TN, Walter Woodrick of Panama City and John Aultman of Picayune, Janet Tucker of Greenville, Dana Smith of Brookhaven, and Michelle Williams of Bay St. Louis. He is also survived by his sister, Retha Guillory of Meridian, 15 Grandchildren, several great-grandchildren and 2 nieces.
