Membership Committee

NACA Sergeant At Arms & Membership Chairman, Robert Uhler

As you are aware, NACA offers four different types of membership. They are General, Associate, Business Associate and Apprentice.

If you are a General or Business Associate, please forward your 2010-2011 membership dues by June 30, 2010.

Associate to General Membership:

However, if you were voted in as an Associate member and will have at least four (4) years of catastrophe property adjusting experience by June 30, 2010, we would like to encourage you to apply for the General membership.

There are only two differences between an Associate Member and a General Member—the number of years of catastrophe property adjusting experience you have and voting privileges with the opportunity to hold office. Adjusters sometimes apply for an Associate Membership because they do not wish to hold office or vote. Due to the differentiation between these two types of membership, the public often considers the General members to be those with more experience. Therefore, it may be advantageous for you to be included in the General Member listing on our website and in the printed roster. (Associate Members are not automatically transferred to a General membership.)

The \$200 membership dues you include with this application will go toward your 2010-2011 membership dues. It will be necessary for you to include all support documentation and letters of recommendation as requested on the application. Please note that all applications and fees must be received in this office by March 15th.

Apprentice to Associate Membership:

However, if you were voted in as an Apprentice member and now have at least one year of catastrophe property adjusting experience, we would like to encourage you to apply for the Associate membership.

The Apprentice Membership was designed to give "newbie" adjusters a starting point in their chosen profession of catastrophe adjusting. If you now have at least one year of property catastrophe adjusting experience, you may want to apply for the Associate Membership. This type of membership is for the catastrophe adjuster with more than one, but less than four years of property catastrophe adjusting experience. It is the next step toward becoming a General Member of NACA®. (Apprentice

2010 CONVENTION REPORT

The 34th Annual NACA® convention was held January 11-14 at the Renaissance Austin Hotel in Austin, Texas. The convention was attended by approximately 250 people. **Eberl's Claim Service** provided bags for registration material and Crawford & Company sponsored the name tags. The Executive Committee and Committee members met on Sunday evening to finalize plans for the convention. On Monday, Beginner and Advanced Software Classes were offered by IntegriClaim, PowerClaim, Simsol and Xactimate. The afternoon class session was sponsored by Action Restoration, Inc. and the afternoon break was sponsored by Reid, Jones, McRorie & Williams. As always, the weather was an issue. On Sunday, the contracted golf course cancelled due to a burst irrigation pipe. Tony Slee and his dynamite committee secured another location quickly and the tournament was held on Monday at the Black Hawk Golf Club. Winning teams were: 1st place - Mike Carli, Bill Nevill, James Nevill, Bob Djordjevic and Josh Dickson; 2nd Place – Kelly Smoot, Doug Harvey, Dale Brassfield and Stan Brown; Dubious Achievement Award went to Randy Stout; Tony Slee won the Closest to Pin and Ryan Siekmann won the Longest Drive. The first day of convention wrapped up with a reception sponsored by Pilot Catastrophe Services in the beautiful Glass Oakes Ballroom. Tuesday morning began with pastries sponsored by Pacesetter Claims Service, Inc. The afternoon cookie break was sponsored by Bracken Engineering, Inc. and the classes were sponsored by Temporary Accommodations. Afternoon classes were "Homeowner's Coverage Analysis: Wind Policy vs HO Policy" presented by Warren Aplin and Chuck Eagle; "Inspecting & Scoping the Catastrophic Property Loss" presented by Michael Ruskin; "Quality Cat reporting for Increased productivity & Profitability – The Top 10 Mistakes Cat Adjusters Make" presented by Chuck Eagle with assistance from Monty Mathias: "Wind vs Flood" presented by Kelly Huff; and the continuation of the "NFIP Adjuster Certification" course. The day concluded with the NACA dinner and dance. The reception was sponsored in part by IAS Claim Services, Inc. Wednesday morning began with pastries and classes sponsored by Nelson Architectural Engineers. Todd Brant presented the class "When Ethical Adjusting Gives Way to Bad Faith" and our keynote speaker, Dr. Dale Henry, PhD, addressed the topic "Ethics: Good Enough Never Is". Dr. Henry was sponsored by Your Florida based Catastrophe Companies: Aplin Peer & Associates, Inc., Burton Claim Services, Inc., IMS Catastrophe Services, Inc., Mathias Catastrophe Services, Inc. and Simsol Insurance Services, Inc. The free vendor show began at 1:00 and was sponsored in part by **Xactware**. Those attending the business meeting enjoyed a buffet lunch sponsored in part by Aplin Peer & Associates, Inc. Tom Vaughan called the business meeting to order with a quorum present. Warren Aplin presented the minutes from the 2009 business meeting and the Financial Report for the period ended June 30, 2009. Both were accepted as presented. Charlie McDaniel presented the membership report. It was reported that we had approximately 250 in attendance at this convention. Shari Britton reported that we had 37 vendors participating in the vendor show. She announced that the show was free from 1pm - 5pm. Warren Aplin, chairman of the Education Committee, reported that 42 hours of education were being offered this year, with 158 hours of state approved CEU's. Charles Norton, chairman of the Website Committee, reported that he had been looking into where NACA appeared on internet search options. Charles will be working to bring NACA up to the first page on many of these search options. There was no "Old Business" to discuss so Tom stepped down from his term as President and introduced the 2010 NACA President, Tressa Bullard. Warren Aplin moved into the position of Vice President and Wanda Hogan into the position of Secretary/Treasurer. Tressa introduced Michael Csom and Michael Hale with CPLIC for updates. John DiStefano presented an overview of the health insurance available through Excalibur Insurance. Tressa opened the floor for nominations for Sergeant at Arms. Bob Uhler and Tony Slee were nominated. A vote was taken by secret ballot and Bob Uhler was elected Sergeant at Arms. Tressa announced that Woody Britton and Charles Norton had been nominated for the honor of Life Membership. Both were approved by a vote of the general membership. Tressa encouraged all who would like to serve on a committee to contact an officer or Lori Ringo. Walter Vance made the motion that the Apprentice Membership applicants be given an immediate membership status. The motion was seconded and the motion carried. The bylaws will be amended as necessary. Charles Norton made the motion that the bylaws be amended to require minutes of all Executive Committee meetings (physical and otherwise) be emailed to the general membership in a timely manner. The motion was seconded and the motion carried. There was no further business and the meeting was adjourned. The Open Forum began after a 10 minute break and lasted for approximately one hour. When the vendor show reopened for paid members at 5:15, it included an array of food stations and drinks sponsored in part by Mathias Catastrophe Services, Inc. and door prizes donated by vendors. Thursday morning began with pastries sponsored by Aplin Peer & Associates, Inc. Classes offered on this final day were "Partner Adjusting" presented by Woody Britton and "Building & Personal Property Coverage Form CP 00 10" presented by Charles Norton. The Executive Committee met immediately following the classes to begin planning for the 2011 convention.
